Establishes and appropriates funds for an Office of Strategic Partnerships and Development to specifically analyze, evaluate, recommend, coordinate, oversee, and manage public-private partnerships that benefit the University of Hawaii. Removes reference to the Board of Regents having exclusive jurisdiction over the internal structure, management, and operation of the University of Hawaii. Establishes a 5-year University of Hawaii public-private partnership pilot project to allow the university to enter into public-private partnerships, under certain conditions. Effective 1/1/2050. <p><u>SB2293 SD2 HD3</u> <u>Hawaii Housing Finance and Development Corporation; Affordable Housing; Maui; Front Street Apartments; Appropriation</u> RELATING TO AFFORDABLE HOUSING.  Requires the County of Maui to pursue remedies to recoup moneys expended for the Front Street Apartments affordable housing project from the owners. Appropriates moneys from the HHFDC rental assistance program as a rental subsidy for Front Street Apartments tenants, subject to matching dollar for dollar funds. Appropriates HHFDC revenues for the expedited construction of the Leialii affordable housing project, subject to the County of Maui expediting the permitting process.
